CAC - The CAC format (described under 901.10.6.) allows competitors the opportunity to select from any one of the listed dressage tests, marathon courses and cones classes from those offered to suit equine readiness, training and preparedness. All entries must use the CAC Entry Form and select one Dressage test, one marathon division and one cones class from those listed. Each competitor is eligible for 1st place ribbons within each division/turnout/class entered. Overall Driving Trial class awards to 4th place are available to eligible entries competing in all three competitions within the same division. The CAC Entry Form is available on the Omnibus web page under "Entry Form" or request from info@blackprong.com. Athletes with disabilities entry must include an ADS, FEI or USE authorized dispensation form. (See ADS GR1.8).

Athlete must be eligible for each division/competitions entered (see 913.3). Driving Trial (DT) entry – on CAC Entry Form select any one Dressage test, any one Marathon, and one Cones competition as well as Turnout and desired class from those offered on the CAC Entry Form. Combined Test (CT) entry – on CAC Entry Form select any one Dressage test, "none" Marathon, and any one Cones competition as well as Turnout and desired class from those offered. This may be a second entry in addition to the Driving Trial or a stand-alone entry. If a second entry using the same horse, it must compete in a different dressage test and/or cones class or one of the entries must be H/C. There are no overall awards for the CT.

Entry limit - drivers may enter either two DT, two CT or one DT and one CT – use separate *CAC Entry Forms* for each entry. Second entry, if same horse/pony/ VSE at this event: DRESSAGE - must be different tests or second entry as H/C; MARATHON - once per event only; CONES - must be different class or second entry as H/C. Entry acceptance: Entries must be complete, legible, signed and include applicable fees, deposits and copies of membership and required horse papers; and be received by closing date. Incomplete entries, missing payments or information and changes are subject to late fee charges.

PSO membership is governed by the province of residence (Cheval Québec, OEF, etc). Non-Canadian grooms must have valid insurance covering equestrian activities. 2. All American competitors must be current members of US Equestrian or ADS and supply copies of membership cards and PL&PD insurance. An Equestrian Canada Sport license or PSO membership is not required. See Online Omnibus for further details regarding: headgear and wristband requirements, order of go, special scheduling requests, required waivers/disclaimers, combining classes, H/C entries, registering in EC, groom requirements, awards, horse bridle numbers, EC Rules, reciprocity, and golf cart/ATV policies.

Prize List/Entry Form

Required health tests and vaccinations: Each horse entering Canada from the USA must be tested with negative results for Equine Infectious Anemia (EIA), using either the AGID or ELISA test, within 6 months of entry into Canada (see further note below), and requires an original US Origin Health Certificate (VS FORM 17-145) certifying the date of EIA test and that the horse was inspected and found healthy within 30 days of entry into Canada. Be sure to use the US Origin Health Certificate as opposed to the Interstate Health Certificate. The VS FORM 17-145 is issued by an accredited veterinarian and must be endorsed by the USDA veterinarian in the state of origin. Horses can enter Canada from the USA at any port of entry. Your health certificate is inspected and released by Canada BorderServices Agency officers (Canada Customs). They frequently keep a copy – so photocopy 1 or 2 extra copies. Keep a copy of your health certificate so you can return to the USA. The VS FORM 17-145 is valid for up to 90 days for return to the USA provided the horse has been at recognized exhibitions/competitions in Canada during the entire stay and provided that the EIA test is still valid, i.e. the horse must have been tested within 6 months of the date of return to the USA. Paperwork for horses returning to the USA within 30 days of entering Canada are inspected and released by US Customs officers. Only horses returning to the USA after a stay of over 30 days in Canada must be inspected by a USDA veterinarian at the port of entry to the USA.





Attention Competitors

All organizers of competitions recognized by The American Driving Society, Inc. (ADS) listed in this Omnibus have agreed to conduct their competition in accordance with the rules, regulations and directives of the ADS.

Any competitors participating in ADS-recognized Combined Driving Events, Pleasure Driving Shows, or Recreational Drives listed in this Omnibus must be thoroughly familiar with the current rules of the ADS and any other organization (such as US Equestrian [USE] and Federation Equestre International [FEI]) by which the competition or drive is recognized. Every class covered by the rules and specifications of the current ADS Rulebook will be conducted and judged in accordance therewith. It is the responsibility of the competitor to know whether or not a class is ADS-recognized, not ADS-recognized, USE-licensed, or FEI-sanctioned.

All ADS-recognized, USE-licensed, or FEI-sanctioned events will be covered by the rules and specification of their respective rulebooks. Failure to abide by the rules can result in elimination. As is printed in the ADS Rulebook (AC-4.3), information published in the Omnibus will take priority over information in the Prize List in the case of conflicting information.

Organizers reserve the right to limit entries, refuse an entry without stating a reason, to cancel, combine or divide a class, or alter the proposed time schedule or officials if necessary. Organizers may refuse to accept an entry that is not completely and correctly filled out, including all necessary health papers, signatures, fees, copies of membership cards, etc. Entry forms are included with the Omnibus and are available for download on the ADS web site (americandrivingsociety.org). Please make sure to use the correct entry form!

ADS Membership

In order to participate in any of the ADS recognized competitions at any level listed in this Omnibus, competitors (drivers only) must be current members of the ADS or pay a non-member fee.
