Entrances to the trail are at Piney Chapel Road just north of Athens and Veto, Alabama at the Tennessee state line

Newly constructed at the Piney Chapel trailhead, is a pavilion with restrooms, parking lot for vehicles/horse trailers, and hitching posts. Also at the Veto trailhead, is the restoration of a 1800's community church and new restroom facilities. The trail hours are daylight to sunset.

Horse-drawn buggy riding requires a free day-use reservation for buggy access behind locked gate. Florida law requires equestrians under 16 to wear helmets. 1-800-423-1476 (FL only) or (352) 796-7211, ext. 4470

**Directions to Site:** Parking: South side of SR 44, two miles west of I-75.

**Conditions at Site:** Abundant and shady parking, accommodates large rigs. Acquired to preserve Lake Panasoffkee's vast floodplain forest, the land also preserves pine flatwoods, freshwater marshes and oak scrub forest. As the land continues to rise, pines and scrub oaks of upland sandhills replace the wetland forest trees. A comprehensive restoration effort of Lake Panasoffkee has been completed to enhance both the water quality of the lake and recreational opportunities.

The two single-track trails (Sanchez and Sidewinder) are not wide enough to accommodate carriages. Please call at least one day in advance to obtain entrance to the carriage gate. On Monday through Friday call 386-462-7905. If calling on Saturday or Sunday, 352-955-2008. All horse riders are required to have proof of negative Coggins on their person or in their saddlebag.

**Directions to Site:** To the Equestrian and Mountain Bike Trailhead: Take I-75 to U.S. 441 (Milepost Exit 399) and drive south 2.8 miles (through the city of Alachua). Turn right onto Progress Blvd. Drive 0.7 miles to the park entrance. (Continue past the end of the pavement and onto the grade road.) Pets, except for horses, are not allowed.

There are approximately 20-30 miles of marked trails at each site.

The newest trailhead is Buck Island Pond and it is on CR 337 too. It is not designed for horse trailers. Tidewater: Yellow 15 miles/ Purple 10 From Dunnellon take CR-40 W to CR-336 N, follow CR-336 N for 5 miles, turn R on CR-337, go .25 mile to dirt road on right and follow to trailhead Black Prong: Orange 10 miles/Black Prong & Blue 6 miles Located on left side of CR-337, 1 mile N of CR-326.

**Directions to Site:** From Baldwin take US-301 N 7 miles, turn right on 1st dirt road after Bryceville Fire Department. Cary State Forest is located in northeastern Florida near Jacksonville in Nassau and Duval counties. Directions from Jacksonville: Take I-10 west to the Baldwin/U.S. 301 exit. Watch for the turns in Baldwin. Drive north on U.S. 301 for 7 miles. When you get to Bryceville, you will go under a yellow caution light and pass by a fire station on your right. Stay on U.S. 301. The main entrance is on the right, 0.5 miles north of the fire station. The green Cary State Forest sign at Pavilion Road is down due to construction on U.S. 301. Turn right onto Pavilion Road (limerock) and drive to the grass parking area. If you pass Pavilion Road on U.S. 301 you will come to the Florida Forest Service Jacksonville District office on Big Oaks Road. Directions from Callahan: In Callahan, drive south on U.S. 301 for 13 miles. When you pass Ford Road, you have only 2.5 miles remaining. Don't turn in at the Florida Forest Service Jacksonville District office on Big Oaks Road. Continue past it 1.5 miles, turn left on Pavilion Road (limerock), and drive down to the grass parking area. The green Cary State Forest sign at Pavilion Road is down due to construction on U.S. 301.

**Conditions at Site:** Slightly bumpy in some areas but generally good and well established roads. There is a hard surface low water crossing along this trail that vehicles use to cross a small creek on North Boundary Rd. Water levels may reach 3-4' in the summer but this crossing remains passable by vehicles most of the year with 1' or less of water. We have had an unusually large amount of rain up into June this year and not every horse in our group would cross water so we drove some of the trails and then got a tour of the rest of the driving accessible trails with the owner in her truck. One of our group did ford one of the creek crossings because she went out a little earlier than the rest of us. The creek beds are flat and sandy with no visible rocks. Water is clear and the bottom is easily visible. No water is more than a foot deep in any of the crossings. However, with all the rain we have had, the approach on both sides of all crossings is water logged sand. The only speakable hills are the descents/ascents to and from the creeks so footing was squishy and would have been quite a pull for some members of our eclectic group of test horses (one 14h Morgan, one old fat Haflinger, one newly trained VSE and one 16h+ Friesian). The Friesian is the one who forded the crossing. Keep in mind that every crossing was doable yesterday but in order to keep our group together and not over work the horses in the heat, we opted out. This property is well worth visiting with a carriage but you must have a horse that is water savvy to take full advantage of the trails available for driving. We plan on returning sometime in the fall because generally, in our area, we have, by then, dried up from little to no rain and the approaches to the creek crossings should be less work for the horses. Please remember that this is rural Alabama and a privately owned farm so it is not a manicured paradise with facilities comparable to some show grounds and campgrounds to which some of us are accustomed. The trade off, however, is the
