### **ADS Rules**

The Tickety Boo Tandem Club is recognized by the American Driving Society, Inc. this event will be held in accordance with the ADS rules as found in the 2024 Rulebook unless otherwise stated in this Prize List as a House Rule class. Every class offered herein which is covered by the current rules and specifications of the Society will be conducted and judged in accordance therewith. The organizers encourage every competitor to be familiar with the General Regulations and Rules for Pleasure Driving Competitions. You may download a free copy of the Rulebook at:

### **Championship Divisions**

**Divisions consist of 5 classes:** Reinsmanship, Turnout, Working, Fault & Out, and Cross Country. Competitors must complete all 5 Classes to be eligible for Division Awards.

**Very Small Equine (VSE);** less than 99cm; with or without shoes.

**Small Pony;** 99cm to less than 120 cm; with or without shoes.

- VSE and Small Pony Divisions will be combined for this event.

**Large Pony;** 120cm to 148 cm with or without shoes; 149 cm with shoes.

**Horse;** equine over 148 cm (with shoes over 149 cm)

**Pairs/Multiples** (any size of equines and configuration)

**Utility** (Marathon) Vehicle\* see below

**Juniors** (youth who will not be 19 years of age on or before December 31, 2024; Article 2.7) At all times while on a carriage or riding an equine, all juniors must wear properly fastened protective headgear which meets ASTM/SEI standards for equestrian use. Article 5.11 Protective headgear must also be worn and securely fastened while riding any equine.

Note: There must be at least 3 entries in a division. Organizers of recognized events may limit entries, refuse any entry, cancel, combine,

or divide a class or division, alter the proposed time schedule or substitute officials if necessary. Article 1.7

\*Please enter the Utility Division (article 215.3.a.) if you have a primarily metal-type vehicle designed for marathon-type use. Marathon vehicles may not enter non-divisional classes.

Entries: An entry (turnout) is defined as a unique combination of horse(s), vehicle, and driver, and must be assigned a unique entry/competitor number. An award may be withheld from any competitor participating in any class while displaying the incorrect or lacking a Number for that turnout/entry. Please use a separate Entry Form for each entry/turnout. Entries Open: 15 February 2024 Entries Close: Postmarked by 20 March 2024.

All VSE and pony entries must submit a current ADS or USEF pony measurement form with their entry.

### **Fees:**

\$15 per Class, \$50 per Division

Junior Class Fee: Juniors receive 5 classes free within a single division. For example: Junior may enter the VSE Division and receive the 5 divisional classes no charge. All free classes must be in the same division. Need not be Junior Driver Classes.

Entries postmarked after 20 March 2024. Entry Fee per Class \$25 for all competitors. As space allows. Entry Fee Refund: full refund prior to closing date less \$25. After closing date full refund less \$25 only with veterinarian letter for animal entered or medical doctor letter for exhibitor. The letter must be received before the beginning of the show, 30 March 2024.

### **Awards**

Medals will be awarded 1st thru 6th place in each class. Championship and Reserve championship crystals awarded in each division. High point

Lady and High Point Gentleman crystal award. Best in Show & Concours d'Elegance Award

Championship points calculated as follows: 1st=6 points, 2nd=4, 3rd=3, 4th=2, 5th=1. Ties broken per ADS article 216.3

### **Stabling**

All equine stalls must display an emergency contact card.

Stall Fee (Fri-Sun) \$25 per night. Shavings: \$8 per bag.

Stalls are permanent with clay floor. Concrete wash rack. Electric in barn. Barn has facilities a feed room with refrigerator and microwave.

Stalls open Friday, 29 March 2024 at 1:00pm. All equines must be removed by 6:00pm, Sunday, 31 March 2024. Trailer Parking in designated area only.

### **Liability**

The American Driving Society, Inc., Tickety Boo Farm, LLC, Tickety Boo Tandem Club, their committees, directors, officers, officials, and staff will not be responsible for any claim resulting from injury or injuries to any person, horse/pony/mule, or loss or damage to property incurred on the show grounds, staging/stabling area, or on any course.

Furthermore, in all situations the driver assumes the responsibility and the liability for any injury or damage to himself/herself, to groom or grooms, and/or passenger/passengers riding with them in the vehicle.

All persons riding on any vehicle or helping a driver in any capacity must sign a waiver which must be on file with the show secretary.

Competitors in violation are subject to disqualification from the show.



All competitors, grooms, navigators, volunteers, event staff, and officials must sign an ADS and Tickety Boo Farm Release of Liability waiver prior to any activity on the facility. First stop after entering the farm will be the show office to ensure all requirements are completed.

### **Dogs**

All dogs must be on a leash.

### **Tires/Wheels**

The use of pneumatic tires is permitted with Marathon Vehicles. The use of wire wheels is permitted only for VSE equines in any class they may enter. Wire wheels are permitted on antique vehicles per ADS Rule Book Article 206.2. No Hyperbikes in any class

### **Safety**

It is the competitor's responsibility to ensure all harness is in good repair and the vehicle is in sound condition. Under no circumstance or condition may a bridle be removed from an equine while it is still put to a vehicle. A throat latch and full nose band/cavesson are mandatory. An appropriate whip must be carried in hand at all times while driving. When an equine is put to a vehicle, a capable person must be on the carriage with reins in hand at all times.

Stallions Junior Drivers and Novice Drivers are prohibited from driving stallions. Health Requirements A copy of a negative Equine Infectious Anemia "Coggins" test dated within 12 months of the show must accompany each entry. ADS requires all equines be vaccinated for Equine Influenza and Equine Herpes (EHV-1) within 6 months of the show date and not less than 14 days prior to arrival on grounds. A veterinary certificate, vaccination form from ADS, or veterinary waiver statement must accompany each entry. For equines not vaccinated due to waiver, a log of body temperature is required twice daily while on show grounds.

### **Class Descriptions**

**Best of Show - House Class.** Judges to consider performance in obstacles classes, overall care of equine(s), the ability and skill of the driver and courtesy with volunteers and competitors. This is judged throughout the show. No entry fee.

**Concours d'Elegance - Article 230** To be judged on the overall impression throughout the competitions. The essence of the competition is the word "Elegance." The winner will be the turnout which, in the opinion of the judge, presents the most elegant effect. This will include the vehicle, harness, appointments, horse(s), driver, passengers, grooms, etc. but above all general impression is most important. Vehicle and harness may be inspected to ensure thoughtful restoration and careful maintenance. Attention will be paid to the personal appearance of the driver, grooms, and passengers as it contributes to the overall picture. Period costumes are definitely prohibited. Performance will not be judged unless it detracts from the elegance of the turnout. By invitation only. No entry fee.

**Carriage Dog - Article 231** Judged primarily on the suitability of the dog to serve as a companion (maximum one dog per vehicle). To be judged both ways of the arena at a walk, slow trot, and working trot. The dog must be standing, lying down, or seated on the vehicle. Dog must be on the vehicle at all times. The dog must be under control at all times. The dog must not be led on the ground from the vehicle or be restrained by being tied to the vehicle, driver, or passenger. The driver should not hold the dog, and the dog should not interfere with the driver in any way.

**Reinsmanship - Article 222** A pleasure driving class in which entries are judged on the ability and skill of the driver. To be shown both ways of the arena at a walk, slow trot, working, trot, and strong trot. Drivers

shall be required to rein back. All drivers chosen for a workout may be worked at any gait requested by the judge and may be asked to execute appropriate tests. The driver should be seated comfortably on the box so as to be relaxed and effective. Either the one or two-handed method of driving is acceptable. Common to both methods, the elbows and arms should be close to the body with an allowing but steady hand enabling a consistent feel with the equine's mouth. Drivers should not be penalized or rewarded for using one general style over the other. To be judged 75% on handling of reins and whip, control, posture and overall impression of driver; 25% on the condition of harness and vehicle and neatness of attire.

**Turnout - Article 217** A pleasure driving class in which entries are judged primarily on the performance and quality of each turnout. To be shown both ways of the arena at a walk, slow trot, working trot, and strong trot. To stand quietly and to rein back. To be judged 70% on the condition, fit and appropriateness of harness and vehicle, spares and appointments, neatness and appropriateness of attire and overall impression; 30% on performance, manners, and way of going of equine(s).

**Working - Article 218** A pleasure driving class in which entries are judged primarily on the suitability of the equine to provide a pleasant drive. To be shown both ways of the arena at a walk, slow trot, working trot, and strong trot. To stand quietly, both on the rail and while lined up, and to rein back. All entries chosen for a workout may be asked to execute appropriate tests. To be judged 70% on performance, manners, and way of going of the equine(s); 20% on the condition and fit of harness and vehicle; 10% on neatness of attire.

**Fault and Out Obstacles – Article 249** A timed course of numbered obstacles to be driven at the trot. The number of obstacles to be

proportionate to the dimensions of the driving area and not to exceed 10 obstacles. After passing through the Start markers, the driver proceeds through each consecutively numbered obstacle, in order, until the allowed time expires (90 seconds), or until an obstacle is dislodged or a disobedience occurs. If all the obstacles are driven cleanly before the allowed time expires, the driver will begin the course again, starting with obstacle #1, without having to pass through the Start markers. Passing through the Start markers more than once is not considered “off course” and is not penalized. Two points will be scored for each obstacle cleared before the allowed time expires, a disobedience occurs or an obstacle is dislodged. When the allowed time expires, a disobedience occurs or an obstacle is dislodged, a signal will be given. The driver then proceeds through the next consecutively numbered obstacle. The time will be taken when the rear axle clears this obstacle. If that obstacle is cleared, one point is scored. If it is dislodged, no points for that dislodged obstacle are scored, but the time is still taken. The score of a driver who fails to drive the next consecutively numbered obstacle after the whistle is blown counts, up to the point where the signal is given, but the competitor must be placed after those with an equal score and time. Placings will be determined by the greatest number of points.

**Cross Country Obstacles Article 250** To be driven over a prescribed course of natural and/or artificial obstacles designed to simulate those that might be encountered on a country drive (i.e., bridges, water, log pile, farm animal pens, etc.) Obstacles should be designed to be easily driven and are not to simulate Combined Driving Obstacles. Obstacles must be clearly numbered. The suggested length of course is approximately 1 kilometer. Should the course design not allow judges to be able to see the entire course while judging, organizers may position spotters to observe and record course violations to be submitted to an event official for final scoring, and spotters will also serve as observers for safety during this class. Spotters should be able

to communicate with an event official during the class. After passing through the Start markers, the driver proceeds through each obstacle, in order, keeping within the limits of the designated course markers and passing through the designated Finish markers. Placings will be determined on a low fault basis (i.e., those with fewer faults finish ahead of those with more faults). Course faults and one fault for each commenced second over the Time Allowed are added together for a total score. The Time Allowed is to be calculated as per Art. 240. Time will decide ties for those with equal fault totals.

### **Tentative Schedule**

Divisions class' will be driven concurrently. For example: VSE Division will enter the arena and be judged on Turnout, Working and Reinsmanship classes. Fault and Out will be held in another area, competitor may drive the Fault & Out course at anytime before or after their Division is judged in the main arena. Cross Country will open at 1:00, each Division start time will be assigned.
