All organizers of competitions recognized by The American Driving Society, Inc. (ADS) listed in this Omnibus have agreed to conduct their competition in accordance with the rules, regulations and directives of the ADS.

Any competitors participating in ADS-recognized Combined Driving Events, Pleasure Driving Shows, or Recreational Drives listed in this Omnibus must be thoroughly familiar with the current rules of the ADS and any other organization (such as US Equestrian [USE] and Federation Equestre International [FEI]) by which the competition or drive is recognized. Every class covered by the rules and specifications of the current ADS Rulebook will be conducted and judged in accordance therewith. It is the responsibility of the competitor to know whether or not a class is ADS-recognized, USElicensed, or FEI-sanctioned.

All ADS-recognized, USE-licensed, or FEI-sanctioned events will be covered by the rules and specification of their respective rulebooks. Failure to abide by the rules can result in elimination. As is printed in the ADS Rulebook (AC-4.3), information published in the Omnibus will take priority over information in the Prize List in the case of conflicting information.



According to Equisure, the company that insures The American Driving Society, Inc., more claims are made each year because of accidents relating to golf carts and ATVs than horses and carriages. We can prevent most of these accidents by using common sense.

Please follow these simple rules:

- Do not allow unlicensed drivers to operate golf carts or ATVs.
- Drive it only on the track of the course or where allowed by the competition. Remember that competitions are often held on private property and that golf carts and ATVs can get stuck on wet ground.
- Don't overload the golf cart or ATV with too many people. This is not only unsafe, but is probably not good for the cart either.

### **Pleasure House Rules**

Country Obstacles (1K) To be driven over a prescribed course of natural and/or artifcial obstacles designed to simulate those that might be encountered on a country drive. Obstacles should be numbered and designed to be easily driven and are not to simulate Combined Driving Obstacles. After passing through the Start markers, the driver shall proceed through each obstacle, in order, keeping within the limits of the designated course markers and passing through the designated Finish markers. Placings will be determined on a low fault basis (i.e, those with fewer faults finish ahead of those with more faults). Course faults and one fault for each commenced second OVER OR UNDER the Optimal Time are added together for a total score. NO TIMING DEVICES ARE ALLOWED. The Time Allowed is to be calculated per ARTICLE 240. Time will decide ties for those with equal fault totals. PENALTIES for Country Obstacles: Time penalties - 1 fault for every second OVER OR UNDER Optimal Time; Knocking down or dislodging obstacle or course marker - 4 faults; Break in gait to canter 1st break to canter - 5 faults, 2nd break to canter - 5 faults, 3rd break to canter - 5 faults, 4th break to canter - Elimination; Prolonged canter - Elimination; Disobedience or groom(s) dismounting anywhere on course (cumulative over course) 1st incident - 3 faults, 2nd incident - 6 faults, 3rd incident - Elimination; Use of timing device - Elimination

Tires/Wheels: The use of pneumatic tires is permitted only in the Utility Vehicle division classes. The use of wire wheels is permitted for VSE equines only in any class they may enter.

### **Pleasure House Rules**

Wade House Pace: To test the driver on his skill in negotiating a crosscountry drive at a prescribed pace over a marked course of any length Drivers are given the speed they are to drive and they must try to come to the finish line as close to the optimal time as possible. Management has the option of adding a walk section which will be clearly marked with "walk" and "resume trot." To be judged on how close the driver's time comes to the ideal time. No watches or timing devices are to be used at any point during these classes. Passengers and grooms are allowed to help the driver. Spares kits are encourage but lack thereof will not be penalized. ADS Article 211 will apply for breaks in gait.

Antique Driver or Antique Horse: Either the horse has to be 18 older or the driver has to be 65 or older. Special consideration by the judges for any turnout that meets BOTH requirements. Judge on 50% Working and 50% on Reinsmanship.

Antique Vehicle Vehicle: is either restored or an original vehicle made before 1950. Class will be judged as a Turnout Class

Best in Show: Entry for this class is by invitation of the Judge. The judge will evaluate all the turnouts he or she has examined on Saturday to choose the one entry he or she feels is the BEST at the show. Winner is completely determined by the judge's opinion.
